(Purchases related to local art and delivery, international transport and installation fees will not be counted as part of the minimum spending).

c. Participants from South Africa must have realized a minimum cumulative spend of R2.5 million, excluding VAT, either in stock or on order, during the period under consideration. The same rule applies to participants based in other African countries, for whom the minimum target is set at €150,000.

For Mauritian participants, the minimum spend requirement is 6.5 million Mauritian Rupees excl. VAT, either stock or on order.

d. Those who are Trade registered with Roche Bobois will still be eligible for their trade discounts (over and above the competition prize). Should you not be registered yet, please contact your nearest showroom in South Africa or Mauritius to sign the form at your earliest convenience.

Winner Selection:

a. The FIRST 12 participants who reach a minimum of ZAR 2.5 million (ex VAT) between 1st July 2023, and 31st January 2024, will be eligible for the trip in 2024.
